15 I, Julian Mena, declare as follows:

16 1. I submit this declaration in support of Plaintiffs' Motion for Attorneys' Fees and
17 Expenses and for Class Representative Service Awards. The matters stated herein are true of my own
18 knowledge or, where indicated, I am informed and believe that they are true. If called upon as a
19 witness, I could and would competently testify as follows.

20 2. I am one of the named Plaintiffs in the above captioned case.

21 3. I understood that, by stepping forward as a named plaintiff in this case, I was taking
22 certain risks, and that it was likely to generate some publicity and be associated with my name in the
23 future. I also was aware of the negative notoriety associated with being a named plaintiff and class
24 representative, and that stepping forward as a plaintiff in this lawsuit may have a negative impact on
25 my ability to find future employment.

1 4. As a named Plaintiff, I have understood my duty to act in the best interest of the Class as
